NON-RESIDENT CULINARY MEMBERSHIP TYPES

1. FULL CULINARY MEMBERSHIP

(Available to Sponsored Non-Residents)

The Full Culinary Membership is designed for non-resident individuals who wish to enjoy the culinary amenities of the River Club. This limited offering is available exclusively to candidates who are sponsored by a current Waterlefe Resident or Waterlefe Golf Member.

Membership Privileges Include:

- Access to à la carte dining at the River Club, the Bistro, & the Poolside Tiki Bar
- Eligibility to attend all River Club-hosted events
- Issuance of a River Club membership card and account privileges with a valid credit card on file

Restrictions:

- This membership does not include access to the Pool or Fitness Center

Fees:

- A one-time, non-refundable \$500 Capital Contribution is required at the time of enrollment
- If a sponsor is not identified, a personal interview may be required prior to acceptance by a board member of the association.

2. RECIPROCAL GOLF CULINARY MEMBERSHIP

(Available Exclusively to Current Waterlefe Golf Members)

The Culinary Reciprocal Golf Membership is an optional enhancement for existing Waterlefe Golf Members who wish to extend their dining privileges within the community and is included with Golf Membership.

Membership Privileges Include:

- Access to à la carte dining at the River Club, the Bistro, and the Poolside Tiki Bar
- Issuance of a River Club membership card and account privileges with a valid credit card on file, or members may pay by credit card at the time of each visit.

Restrictions:

- This membership does not include access to the Pool, Fitness Center, or River Club-hosted special events

Fees:

- There is no fee associated with this upgrade for current Waterlefe Golf Members

TERMS & CONDITIONS

(Applies to both culinary categories.)

1. Property Disclaimer

The Club shall not be held liable for the loss, theft, or damage of any personal property brought onto Club premises by members or their guests.

2. Club Account and Billing

Full Culinary Membership requires a valid credit card on file or enrollment in a pre-authorized debit plan. All purchases made at the Club will be automatically billed on a monthly basis.

Monthly statements are available at www.waterlefemembers.com.

Reciprocal Golf Culinary Members may keep a credit card on file, or can pay by credit card for transactions at the time of each visit.

Note for All Members: A 3% credit card processing fee will apply to all transactions at The River Club.

3. Minimum Purchase Requirement

Full Culinary Members are required to meet a minimum food and beverage purchase of **\$1,000 annually**. If the minimum is not met within the required timeframe, the shortfall will be billed accordingly.

In the event of resignation, the minimum purchase requirement will be **prorated through the resignation date**, and any shortfall will be billed accordingly.

4. Guest Policy

Culinary Members must accompany their guests while on Club property. Unaccompanied guests are not permitted.

5. Club Rules, Conduct, and Liability

Members must comply with all current and future Club policies and guidelines. Members are also responsible for the conduct of their guests. Any damage to Club property caused by a member or guest due to willful misconduct or gross negligence will be billed to the member's account. Appropriate attire and respectful behavior are required at all times.

6. Modification of Membership Terms and Policies

The Club reserves the right, at its sole discretion, to revise or terminate any Culinary Membership, modify these Terms and Conditions, and adopt new or amended Club policies at any time. If a member finds such changes unacceptable, they may resign their membership by submitting written notice within **thirty (30) days** of the change. Continued use of Club facilities after that period will be considered acceptance of the changes.

7. Resignation and Account Closure

All resignations must be submitted in writing and received by the Club within thirty (30) days of the intended resignation date. Members remain financially responsible for all charges and

obligations incurred prior to the effective date of resignation, including any prorated minimum purchase requirement. Verbal resignations will not be accepted.

8. **Photography Policy and Use of Images**

From time to time, photographs may be taken at Club events and within Club facilities for use in publications, marketing materials, or online platforms, both for members and the general public.

- a. By entering Club premises or attending Club events, members and their guests acknowledge this practice. If you or your family members do **not** wish to be photographed or have your images used, it is **your responsibility to inform the photographer at the time the photo is taken.**

- b. Unless an explicit objection is communicated to the photographer, **Waterlefe Golf & River Club reserves the right to use any such photographs in marketing or promotional materials at its discretion,** without further notice or compensation.
